# The Gift of Forgiveness: Lessons from the TRC

Professor of Psychology, Pumla Gobodo-Madikizela, was in the U.S. recently, speaking about her work on the use of testimonial narratives in working through trauma.

A clinical psychologist with a PhD from UCT, Gobodo-Madikizela served on the Human Rights Violations Committee of the Truth and Reconciliation Commission (TRC). She initiated a TRC outreach program in the Western Cape, where she was co-ordinator of victims public hearings. She reflected on her experience in her critically-acclaimed book, A Human Being Died That Night: A South African Story of Forgiveness, which won the Christopher Award (2003) and the South African Alan Paton Award in 2004.

This year she published *Narrating Our Healing: Perspectives on Working through Trauma* with UCT Professor, Chris van der Merwe. The book considers the process of recreating lives that have been shattered by trauma. "In dealing with trauma there is a tension to tell what happened and not

to tell because it's so painful," says Gobodo-Madikizela. For that reason, narrative heals.

While in the U.S. Gobodo-Madikizela spoke with a gathering of Congressional leaders in Washington, D.C. At the invitation of Connecticut Congresswoman Rosa DeLauro, Gobodo-Madikizela led a dinner discussion on trauma and healing. She drew some parallels between the trauma experienced by young white army conscripts during apartheid—and the impact on their families—and the challenges facing the U.S. in relation to the "wounds of war" experienced by men and women returning from the Iraq war. She shared insights drawn from her work on the TRC, particularly how collectively experienced trauma can be a force that restores unity in a divided society.

From Washington, D.C. Gobodo-Madikizela traveled to Dallas, Texas, where she gave a keynote address on forgiveness and reconciliation at the 3rd International Women's Peace Conference.

## Law Faculty Builds Ties with Top U.S. Law Schools

## University of California Partnership Renewed

UCT recently renewed its exchange agreement with the University of California. During their trip to the U.S. in May, Professors Ndebele and Nhlapo were delighted to meet with UC Education Abroad staff and faculty from UC Santa Barbara at a formal signing ceremony held to mark the continued exchange, which will run through 2012.

The UC partnership is just one of UCT's many agreements with partner institutions worldwide. Over 145 UCT students have gone on exchange programs since 2002. Two students who have benefited from the UC partnership share their views on the transforming power of exchanges.

### Student Leaders in D.C.

This summer four UCT students participated in the South Africa Washington-Ireland Program/SAWIP, a new outreach of the Washington-Ireland Program for Service and Leadership (WIP).

Since 1995, WIP has brought 30 students annually from communities in Northern Ireland and the Republic of Ireland to Washington, D.C. for summer internships and leadership training.

UCT students and inaugural SAWIP alumni from 2006, Reitumetse Phirri and Michael Currin, helped extend the youth development program to South Africa.

The 2007 SAWIP team comprised three UCT Law students-Mzimkhulu 'Zim' Ceko, Jean Scrimgeour and Caroline Taylor—as well as Commerce student, Olebile Gaobepe. The organizations for which they worked included the International Finance Corporation's Grassroots Business Initiative, the Council for a Community of Democracies, the Centre for International Private Enterprise, and the American Civil Liberties Union.

UCT students also met with the Whitman Walker HIV-AIDS Clinic, and shared their ideas about the future of Africa in a session sponsored by Congressman Donald M. Payne, Chairman of the Subcommittee on Africa and Global Health. The SAWIP team responded strongly to the program's goal of encouraging initiatives to enrich the lives of others. As Jean Scrimgeour said: "I love the idea that I am, by virtue of where we are as a country, able to make a difference, one that can last."

Stephen Segal (BPharm 1989) works as an Oncology Pharmacist for the Moores Cancer Center at UC San Diego.



# **Dreaming of Travel**

"Reisemalheurs" (Travel Woes), an exhibition of paintings by New York-based Michaelis graduate, Vivienne Koorland, was shown recently at the Freud Museum in London to critical acclaim.

Koorland's "heady paintings", noted a review in Time Out, offered an "uncommonly persuasive pretext" to visit the Museum, taking the viewer "out of the jostling, relic-rich space they're situated in, convincingly into the divisions caused by past catastrophes and, furthermore, into the landscape of the common mind."

"Reisemalheurs" was coined by Freud in his private correspondence to capture the discomforts and difficulties of travel. Taking inspiration from this emotive term, Koorland addresses both the anxiety associated with travel as well as broader themes of displacement and dislocation. In hand-stitched canvases densely covered with various symbols and texts-children's drawings, maps, handwritten lists and place names-Koorland's paintings evoke both personal journeys and social displacements.

Koorland's work will be on show again in London in February 2008, as part of an exhibition on Contemporary South African Art at the Haunch of Venison Gallery. The exhibition will include work by Santu Mofokeng, one of South Africa's foremost photographers, and Amsterdam-based Moshekwa Langa. www.haunchofvenison.com



#### Banner Year for Research

The African component of the International Centre for Genetic Engineering and Biotechnology (ICGEB) opens this month at UCT. Hosted by UCT's Institute for Infectious Diseases and Molecular Medicine, the research laboratory is expected to result in new drugs and vaccines in the fight against TB, malaria and HIV/AIDS.

The selection of UCT to host the ICGEB is the latest in a series of national and international awards that recognize the university's research excellence.

In 2006 UCT was awarded one-third of the first 21 national research chair appointments, created under the Department of Science and Technology's (DST) South African Research Chairs Initiative. New research chairs include Professor George Philander, a UCT graduate who was recruited to UCT's Marine Research Institute from Princeton University.

UCT has also benefited from the DST's move to establish Centers of Competence as lead sectors to position South Africa in the global knowledge economy. The Chemical Engineering Department was recently awarded R30-million to establish a Catalysis Competence Center, one of three centers nationally to develop hydrogen and fuel-cell technologies in South Africa.

#### **Vice-Chancellor Selection Process**

The process of selecting UCT's tenth Vice-Chancellor is well underway, with the University Council expected to appoint a Vice-Chancellor Designate at the end of 2007.

Vice-Chancellor Njabulo S. Ndebele, who steps down in the middle of 2008, has made many important contributions to higher education during his seven years of service. He is Chair of the Southern African Regional Universities Association, and President of the Association of African Universities. He is also on the Board of Trustees of the Nelson Mandela and Mandela-Rhodes Foundations. As a public figure, he is known for his incisive insights on a range of issues facing South Africa in its ongoing transition.

Applications and nominations are currently being reviewed by the 20-member Selection Committee. Chaired by UCT alumnus and human rights lawyer, Geoff Budlender, the Selection Committee is broadly representative of the university community. #### **SRC Celebrates Centenary**

2006 marked 100 years of student representation at UCT. This year, UCT is commemorating the centenary with a number of events honoring not only the Students' Representative Council (SRC), but also student leadership in general.

The celebration opened during June graduation with a photographic exhibition, 100 Years of SRC. The highlight of the celebrations will be a gala dinner planned for September, welcoming all SRC Alumni back to campus. The current SRC plans to launch the SRC Trust Fund at this event. The Fund will be used to provide financial assistance to UCT students from modest family backgrounds who fail to meet the national means test for financial aid, but who nevertheless lack the full resources for a UCT education. The SRC has already raised well over R200 000 towards the Fund.

## Hold the Date: Judge Dennis Davis in New York, Thursday, September 27, 6-8pm

Please join us for a discussion with Dennis Davis, hosted by the UCT Fund and the South African Chamber of Commerce America (SACCA).

Dennis Davis is a Judge of the High Court of South Africa, and Judge President of the Competition Appeals Court. He has also served as a Judge of the Labour Appeal Court. He has delivered a number of ground-breaking judgments, while continuing to write



prolifically across a broad spectrum of the law. He is also well-known for his pioneering use of television to address critical issues of law and justice.

Before his appointment to the Bench, Dennis Davis held appointments at the law schools of the University of Cape Town and University of the Witwatersrand. He received a BCom LLB (cum laude) from UCT and a MPhil from the University of Cambridge. Last year he received an honorary doctorate from UCT, where he teaches courses in tax, competition and constitutional law.
